## 2010 Contract for Services for Community College Volleyball Officials

It is hereby agreed between \_\_\_\_\_ (herein called the requestor) and the Tacoma-Pierce County Volleyball Officials Board (herein called the provider) that this official's organization will provide officials in accordance with this agreement for the period of August 15, 2010 to December 31, 2010.

### **A. FEES:**

1. Match Fee for regular season league play will be \$155 in 2010.
2. Match Fee for post-season playoffs will be negotiated for 2010.
3. Line Judge and/or Scorekeeper fee for all regular season and post-season play will be charged at a rate of 50.00 per match plus \$10 per official for mileage.
4. Mileage will be based on AAA gas costs effective 9-1-10.
5. Assigning Fee will be charged at a rate of \$200.00 per season.
6. Billing Fee: None.
7. Schedule Change Fee: None
8. Crossover Tournament Match Fees: Match fee for all formats to be negotiated/official/match

### **B. PAYMENT:**

1. One check for the entire sum will be paid to the provider within 45 days upon receipt of a bill.

### **C. PROVISIONS:**

1. The request for officials must be made no later than May 15th on the official form as provided by the provider.
2. Warm-up policies and any other special rules are as per league approval and must be provided to the provider no later than May 15th unless special arrangements are otherwise made.
3. The requestor agrees to have the facility and participants ready to play at match time.
4. The requestor agrees to have dressing facilities for the officials.
5. The requestor will provide an on-site supervisor to be present during all matches.
6. The provider will assign two certified officials to all contests unless otherwise stipulated by the requestor. Line Judges/Scorekeepers are subject to availability.
7. Officials not notified of a match change and show up to referee will be paid in full.
8. Provider will assign officials, at no charge, to at least one (1) practice match prior to September 1. Request must be made no later than August 1.
9. Coaches will submit online evaluation forms within five (5) days of match.
10. Matches will be posted on [www.arbitersports.com](http://www.arbitersports.com) no later than July 1 at which time it is the requestor's responsibility to verify that dates and times are accurate. If a school fails to confirm the accuracy of the matches and an official reports for a match that is not being held, the school will be responsible for paying the full match and mileage fees to all officials.
